## Creative Movement

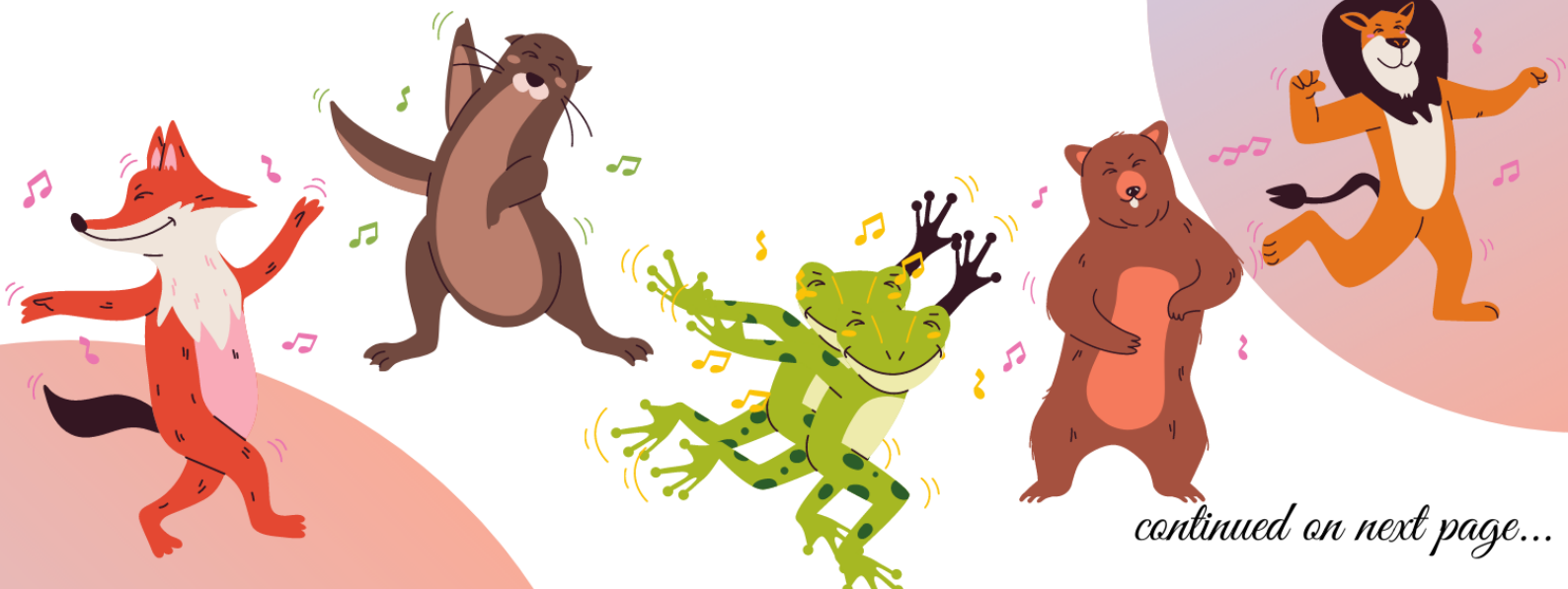
